Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to https://www.emblazingminds.org/ and Emblazing Minds Institute and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Emblazing Minds Institute include https://www.emblazingminds.org. The Emblazing Minds Institute website is a Educational Services site. By using the Emblazing Minds Institute website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Emblazing Minds Institute may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address

If you purchase Emblazing Minds Institute's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. Use of your Personal Information

Emblazing Minds Institute may also use your personally identifiable information to inform you of other products or services available from Emblazing Minds Institute and its affiliates.

Sharing Information with Third Parties

Emblazing Minds Institute does not sell, rent or lease its customer lists to third parties.

Emblazing Minds Institute may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. Tracking User Behavior

Automatically Collected Information

Use of Cookies

SSL Protocol

- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or

prosecute those responsible for that activity;

- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

Children Under Thirteen

Emblazing Minds Institute does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this website.
